



2021 DNA TESTING GRANT

When considering the success of the previous *Legacy Grant* and the motion that was approved at the December 2017 Newfoundland Pony Society's AGM;

Be It Resolved: That the Newfoundland Pony Society Executive Council continue to give priority to making improvements in the Registration system for Newfoundland Ponies, completion of the Registration Manual Project and consideration of registration policy issues and seeking to have registered as many registerable Newfoundland Ponies as possible;

The Newfoundland Pony Society will be offering **free DNA testing to 50 qualifying ponies**.

Who can apply?

- Anyone who owns a Newfoundland Pony (or suspected Newfoundland Pony) is eligible to apply! That includes NPS members, as well as non-members.

Where do I start?

- Pony owners are asked to submit the attached application to NPS (via mail or email), documenting all known information about the pony that you wish to have considered for the 2020 DNA Testing Grant.
- The application will be reviewed by the NPS ID committee to determine the likelihood that that animal under review is a Newfoundland Pony. If the ID committee finds that there is reason to believe that the pony in question is a Newfoundland pony, the owner will be notified and the \$50 DNA testing fee will be waived.

- Owners will have 60 days to submit their DNA hair sample once a DNA Request Form has been forwarded to them by the NPS registrar.
